# DATA DICTIONARY

## 777 W & I

The California Welfare and Institutions Code that outlines a petition filed in juvenile court alleging that a minor violated their court ordered probation terms. Also commonly used as a booking code for "adjudicated" and "non-adjudicated" youth in Santa Cruz, County for minors placed into juvenile hall for probation violations, warrants, court remands or violations of home supervision or electronic monitoring.

*NOTE: Santa Cruz County Probation currently uses 777 W&I for bench warrants; however this is not the W&I code definition of warrants.*

# Abscond Absent Without Leave (AWOL) -Home

A minor who leaves any Court ordered placement without permission. (The two can be used interchangeably).

# **Adjudication**

Judicial determination in which the minor's case has been concluded with a finding by the court or an admission by the minor.

# Admission

A youth is admitted to detention if held at Juvenile Hall more than four hours.

#### Arrest

When a Peace Officer takes a person into custody, and /or issues a citation for an alleged violation of the law or probation.

*NOTE: An alternative legal definition of arrest differentiates arrest from citation, as arrest implies loss of liberty and citation does not.*

# Average Daily Population (ADP)

The average daily includes the average number of youth in the detention facility in a given period of time.

How Measured:	Average daily population (ADP) is calculated as follows: (# of releases * LOS)/# of days in the reporting period. ADP is calculated based on releases and is therefore not the exact measure that would result from taking an average of the daily population during the given reporting period.

# Average Length of Stay (ALOS)

The average length of stay for all youth in a detention facility for any given time period.

#### **Bed Days**

The number of custody days served by individuals over a period of time.

#### **Bench Warrant**

A Bench Warrant is an order issued by the Court mandating that a minor be brought before the Court.

#### Bench Warrant: Types (Bench warrants by type are not currently being measured)

**Releasable:** An arrest warrant that is releasable at a Probation Officers Discretion - The Court makes this determination and it is noted on the warrant.

**Non-Releasable:** An arrest warrant that is not releasable at a Probation Officers discretion - The Court makes this determination and it is noted on the warrant. This includes out-of-County and out-of State warrants.

Traffic:Traffic warrants carry no custody time.The Institutional Supervisor assigns anew traffic court date; the minor mustthen be released to a guardian.

**CPS W & I:** Minors with such a warrant may be held during the evening and early morning hours as a courtesy to Child Protective Services (CPS) but must be segregated from other minors.

## Booking

When a youth is received by juvenile hall after an arrest by a peace officer or is sent to the juvenile hall by the juvenile court.

# Citation

A legal document issued by a peace officer for an alleged violation of the law or probation.

## **Commitment (Court Commitment)**

A Disposition order requiring a minor to spend a specific amount of time in custody at Juvenile Hall, Ranch Camp, or Division of Juvenile Justice (DJJ).

#### Detention

The restriction of a minor's freedom by being placed under arrest in Juvenile Hall, on Home Supervision or Electronic Monitoring.

NOTE: Santa Cruz does not capture detention from the point of arrest by law enforcement to booking.

#### **Detention Hearing**

A hearing conducted in juvenile court resulting in a decision as to whether a minor should remain, be placed, or be released from a form of detention such as juvenile hall, home supervision, or electronic monitoring. If a minor is detained on home supervision or is in custody, the law requires that within 24 hours after a petition is filed (excluding weekends & holidays), the charges must be brought before judge in juvenile court.

# Dismissed

A finding by the Court that the District Attorney does not have sufficient evidence to support the claim petitioned.

## **Dismissed and Considered**

A charge (or more multiple charges) on a petition which are not admitted by the youth in exchange for a plea agreement. The charges can be included for probation terms (such as restitution and stay away orders).

#### **Diversion**

Any delivery or referral, by the probation department, of a minor to a public or private agency with which the city or county has an agreement to provide diversion services without probation services. An opportunity to avoid the formal adjudication process.

# FTA (Failure to Appear)

A youth's failure to appear for a scheduled, court mandated appointment.

A group of three or more persons who have a common identifying sign, symbol or name, and whose members individually or collectively engage in or have engaged in a pattern of criminal activity creating an atmosphere of fear and intimidation in the community.

#### **Gang Member**

# **HSUP/EMP** Failure

A youth who has been removed from the Home Supervision or Electronic Monitoring Program by the Court for not following Court ordered rules.

# Informal Probation (654 W & I)

Supervision of a minor, in lieu of a petition and a formal adjudication process, for a period not to exceed 6 months. The supervision is based on contractual agreement between the probation officer and the minor's parents or guardian. Typically applied after a diversion opportunity.

# Informal Probation (654.2 W & I)

Supervision of a minor, for a period not to exceed 6 months. The supervision is based on contractual agreement between the court and the minor's parents or guardian. The minor is given a 6 month court review date and if all terms are completed, the original petition is dismissed.

#### **Mandatory Detention**

A minor 14 years or older who is arrested and brought to the Juvenile Hall for a 707(b) W & I offense, any felony involved in the use of a firearm, or a non-releasable Bench Warrant shall not be released from the Juvenile Hall prior to being brought before a Judicial Officer.

#### **Override**

A decision to detain or release a youth prior to their Detention Hearing contrary to the outcome recommended by the RAI. NOTE: Overrides may be based on policy or upon recommendation to and approval of a manager.

Override Down:	The release of a youth with a high RAI score.

#### **Override Rate**

# **Petition Filed (Filing)**

A formal, written request by the District Attorney, a Probation Officer, or a defense attorney to the Court which initiates or modifies a delinquent action against a minor. This can take the form of a probation violation, a new charge, a request for dismissal of probation, a request for modification of a court order, etc.

### **Pick Up and Detain Order**

A written request from a Probation Officer to pick up a minor and bring them to the juvenile hall. It is temporary and must be followed with a simultaneous request for a Bench Warrant.

## **Policy Hold**

Reason the department has decided a youth will be held in detention regardless of their RAI score. #### **Pre-Disposition / Post Disposition**

**Pre-Disposition:** 

The time while a minor is going through the juvenile court process on a petition prior to disposition (equivalent to sentencing in Adult Court). This period of time varies depending on the seriousness of the allegation.

**Post Disposition:** 

Refers to the period of time after a minor has received a disposition (sentencing) order from juvenile court.

#### **Probation Status**

Also commonly used when referencing minors whom have a bench warrant. Non court ordered probation includes diversion and informal contracts.

## **Race and Ethnicity**

Race is a social construct that was created to categorize people into designated groups (e.g. Black, White) based primarily on appearance.

Ethnicity is a social, not biological, category referring to social groups, often sharing cultural heritage and ancestry (e.g. Latino, Arab). Santa Cruz County uses the following racial and ethnic categories: African American; American Indian; Anglo; Cambodian; Chinese; Eastern Indian/ Asian Indian; Filipino; Guamanain; Japanese; Korean; Laotian; Latino; Native Hawaiian; Pacific Islander; Samoan; Vietnamese; Other Asian; Other/Mixed; Unknown/Unreported.

### **RAI Score**

The RAI, or Risk Assessment Instrument, is a written checklist of criteria that are applied to rate each minor for the risk of re-offending before adjudication and of failing to appear for a court hearing. The RAI assigns points for various risk factors and subtracts points for mitigating factors; producing a total RAI Score which indicates whether the minor is eligible for Secure Detention, for a release with conditions or a release without conditions.

### **Ranch Camp**
