#### WATER FORUM HIGHLIGHTS COLLABORATIVE EFFORTS FOR WATER MANAGEMENT IN SANTA CRUZ COUNTY

On January 28, the public is invited to a discussion of local water resources and environmental protection featuring leaders from across Santa Cruz County.

Water is one of our most precious common resources. As water managers and community members work to address water issues for their community, they are finding that the most effective approaches involve reaching out and working together on regional solutions. õConnecting the Drops: Working Together for Waterö will bring together a variety of voices for a discussion featuring keynote speaker John Laird, Californiaøs Secretary for Natural Resources, as well as information stations on water recycling, groundwater management, water conversation, and watershed management. The event is free and open to the public.

Water issues have a significant impact on Santa Cruz County residents and the environment. Within four years, the drought has reduced streamflows in the San Lorenzo River to historic lows while drying up other streams and sharply lowering water levels in Loch Lomond Reservoir, threatened the water sources of several small water systems, and driven county residents and businesses to reduce water use to some of the lowest levels in the state.

Local water resource issues extend beyond the drought, with most of the countyøs groundwater basins depleted by over-pumping, coastal water quality degraded by urban runoff and leaky sewer systems, salmon and steelhead populations diminished by low streamflow, sediment and loss of large wood in the stream, and wetlands and riparian corridors diminished by land development and agricultural use.

Local governments, water agencies, and community members have responded in a variety of ways, including initiating community water dialogues in Santa Cruz, the Mid-County area and the Pajaro Valley; implementing some of the highest levels of residential and agricultural conservation in the state; expanding the use of recycled water; restoring groundwater recharge, constructing interties and promoting exchange of water among districts; and pursuing state funding to help reduce local costs to address these issues. Connecting the Drops will highlight and bolster these ongoing efforts.
