3.4. Jail population: 28 women in custody

3.4. Main Jail: G Unit, 10 women; H Unit, 6 women; O Unit, 2 women.

3.4.1.1.1. Women in H Unit restricted to cell.

3.4. Blaine Street: 10 women, 5 enrolled in WRRP.

3.4. 14 women in custody on bench warrants, some also with fresh charges. Will clarify numbers at next subcommittee meeting. 6 women on releasable to program list from 3-32 days (women waiting for 32 days has mental health

priority and challenges finding appropriate placement).

3.4. Author Jeri Ross visited women in Blaine Street as part of their enrichment

program. Read excerpts from her book and ended with well received

breathing meditation.

3.4. JAG holiday contributions including \$10 on each womans books and holiday

cards were distributed for the fourth year. Didn't get to do polaroid photos

this time.
