    - 3.2. New Life is at capacity with a 2-3 week waiting list. 6 women in residential treatment. 2 children with a parent. Still pursuing South County to expand services.
    - 3.2. Gemma: 4 women in residence, another coming in later this month.

### 3.3. Jail Update

- 3.3. Jail population: 30 women in custody
  - 3.3. Main Jail: G Unit, 16 women, 5 enrolled in classes; H Unit, 6 women.
  - 3.3. Blaine Street: 8 women, 5 enrolled in WRRP
  - 3.3. 5 women in custody on bench warrants, 2 women on releasable to program list.

3.3. In person contact visits reinstated September 2024 for 1 hour per month for children of women at Blaine Street. No visits to date. One scheduled for January 2025.

#### 3.4. Library

- 3.4. Partnering with Rising Scholars and Cabrillo College librarians to support students at juvenile hall who are taking online Cabrillo classes.
- 3.4. One woman in Blaine let us know she is dyslexic, and library is now piloting audio books for women in Blaine Street. Positive response so far!

Participants emphasized the need for transitional support, effective aftercare, and building strong rapport to bridge gaps and enhance service continuity
