#### 4.1. Rebecca Garcia:

- attended the Board of Supervisors meeting, thanks to the women who spoke.
   Question: emailed Leeann to thank her and requested JAG report on decision-making and what it will look like going forward
- 2. Emailed Nicole after email about motion to add Susan's contract to the agenda. Failed to ask for Emergency motion and approval. Incorrect allegations from Nicole that the commissioners were in violation of the Brown Act during the meeting. County counsel recommended that the conversation be paused. Believes this was an attempt to discredit Susan.
- 3. Staff to add electing a chair or co-chairs for the subcommittee to next agenda since staff is too overwhelmed. Establish bylaws; staff to bring commission bylaws and refer to bylaws.
- 4.2. Lynne Petrovic: Biological harm is being done. How do we continue the movement Susan has started? Commission and mission comes first.
- 4.3. Sarah Marschall: Hard for staff to highlight issues in systems. There is a need for professional and outside perspective.
- 4.4. Susan to share guidelines and commission materials with co-chairs
- 5. Discussion: Reducing harm to children of incarcerated parents (Information Only)
  - 5.1. Point of Arrest
    - 5.1.1. Santa Cruz Police Department has new policy about how to handle the situation when children are present at the time of arrest
    - 5.1.2. Localities have adopted Children's Bill of Rights. Staff to request policies from jurisdictions and information about how it is executed: information from San Francisco and Alameda counties. Rhyme policies and practices; how can this be reported?
