 - 3.3.1. \$700,000 needed to be cut in professional services and the County is facing real tradeoffs
 - 3.3.2. Stipends for commissioners or speakers are not being cut
 - 3.3.3. Community Correction Partnership awarded funds to Gemma House
- 3.4. Janus taking over Gemma house, beds will remain for women
- 3.5. 35 women in custody
 - 3.5.1. 11 in Blaine, 14 in G Unit, 7 in H Unit, 3 in O Unit
 - 3.5.2. New programs at Blaine: Culinary Programs and Master Gardners
