When you click on the meeting link, you will be asked how you want to join the meeting. If you already have the Teams app, you will be asked to open it. If you do not have the Teams app you can download the Windows app. The easiest way to join is to select to continue on your browser, no download or installation is required. You will automatically be asked if you want to join the meeting. Commissioners are expected to join with a video camera. Public attendees may choose to have their cameras on or off.

Please join the meeting a few minutes before 5:00 pm so that we can start at 5:00 pm. Staff will open the video conference at 4:50 pm. Feel free to chat and say hello before 5:00 pm.

### Meeting Roles and Rules:

All meeting attendees should keep their microphones on mute unless they are speaking.

The Chair of the Commission will lead the meeting. The Chair will announce each agenda item, identify who will be leading an item and introduce discussion and public comment periods.

During a discussion, if 2 or more people speak at the same time, please defer to the person who speaks first. In any moment where we have some confusion due to multiple people wanting to speak, please pause and let the Chair take the lead. The Chair will call on someone to speak.
