Response explanation (required for a response other than Agree):

There has been significant engagement and interest in development of broadband infrastructure. The County Broadband Master Plan was updated in 2017. In 2017-18, the Office for Economic Development conducted a Broadband Survey and provided results to service providers. In Fall 2018, two community meetings were held in Felton and Aptos inviting local service providers to present and meet directly with interested residents one-on-one at tables after the presentation. Several providers attended including Comcast, AT&T, Spectrum, Ridge, Cruzio, Surfnet among others. The largest barrier is the cost of developing this infrastructure. In April 2021, the Board directed staff to set aside \$500,000 in American Rescue Plan Act of 2021 funds for the purpose of expanding broadband access. In August 2021, the Board authorized the Information Services Department to release a Request for Proposals (RFP) for companies to provide broadband services in unserved/underserved areas of Santa Cruz County.

 - 1) the special difficulties and costs posed by rural broadband infrastructure;
 - 2) the challenges and infrastructure achievements in 2020 due to the COVID-19 crisis; and
 - 3) opportunities for new funding sources and due to regulatory changes from the California State and Federal Government and how they are to be coordinated with the efforts to date to provide distance learning and broadband access. (F1, F2, F3, F6)

Required response explanation, summary, and timeframe:

The 2015 Master Plan was updated in March of 2017. The update addressed the difficulties and costs of improving rural broadband infrastructure. COVID-19 has not been a significant factor regarding broadband challenges and infrastructure achievements in 2020. The County has not yet experienced widened opportunities to implement broadband access. New State and federal funding is not available to the County to date, but staff are continuing to monitor and track for new opportunities. For example, in April 2021, the Board directed staff to set aside \$500,000 in American Rescue Plan Act of 2021 funds for the purpose of expanding broadband access. In August 2021, the Board authorized the Information Services Department to release a Request for Proposals (RFP) for companies to provide broadband services in unserved/underserved areas of Santa Cruz County.

The County is not positioned to establish, own, manage, or operate its own broadband access systems due to cost and the rapid speed of technological change. Implementing County-based broadband would be duplicative of private sector efforts to do the same.
