Corinne Hyland; Health Services Agency

- Data Dashboard on HSA website
- -929 active known cases
- -210 deaths
- -18,340 known cases since the beginning
- Notes:

-Delta has changed the way we look at Covid; transfers easily from person-toperson; not easy to track; don't know where people are getting exposed. -Reason for face covering mandate (whether vaccinated or not): transmission is

high in our area.

-Had a big trend upward, looks like we are now rounding the top and hoping to get over the surge. Also seeing slow decline in hospitalizations.

-In July each person was infecting two people; now gone back to under one. -Effects on race/ethnicity now are more equal.

-Vaccines are being equitably distributed across our county.

-School guidance: on HSA website, link underneath data dashboard -Testing sites all listed on website.

- Phase one: Debris removal nearing completion.
- Working with Long Term Recovery Group and Policy Holders United.
- Received a briefing on Atkins Study—paid for by Community Foundation Fund; providing better data—will help inform rebuild efforts and upcoming debris flow preparation

- Severe drought in CA; no significant rain in sight
 -We are currently just below the maximum historic levels—went down due to
 marine layer. But fuels (grasses and trees) dry and susceptible to carrying
 fire.

 -Can sort by zone
 - -Yellow highlights approaching red flag warning
- More warm and fair weather on the way.
- Outlooks from US Forest Services highlight entire bay area including SC County as high threat, due to excessively dry fuels
- CZU recovery:
 - -Burn scar didn't get much rain last winter to break up soils and increase germination; haven't seen a lot of green-up

-Over next month looking at this closely to determine debris flow thresholds

-Sonoma had created Office of Recovery and Resilience-a model that Santa Cruz looked at

-Bringing together the four main pillars: preparation/readiness, response, recovery, and mitigation- all interrelated.

-Announcing that Dave Reid is the new Director

-Impacts of COVID and then the largest wild land fire in the county's history -Working to get processes in place.

Information gathering through After Action Report (AAR):
 -Gaps identified: people not trained for positions they were put into; need to develop system for position-specific training; lack of staffing (especially PIO,

Shelter and Care, Finance);

-Strengths: people stood up amazingly well

AAR will be a document moving forward

Findings, recommendations, and OR3 activities under way:
 -Comprehensive County Disaster Service Worker (DSW) program being developed

-Scale down level of staff and activity in the EOC during activation: return to coordinating hub; keep EOC as a place of calm

-Upgrading program for workshops and exercises

-Reviewing technological upgrades and reconfiguration for EOC

-Developing activation guide for EOC Duty Officer, and clarifying processes -Looking at values, strategic statements, having grants meeting needs and identified outcomes

-Working closely with Firesafe Council, RCD, Sempervirens, and other partners for comprehensive fuel treatment strategy. Looking first at areas with ingress/egress issues to work to save lives.

-Have short-term goals through December, now working on plan through July 2023.

-Updating Emergency Plan

-Addressing climate action strategies.

-As of August, 67 percent fully vaccinated for COVID in 95076 -Re drought: public works/utilities have asked for reduction of outdoor water use by 50 percent

-Fire Department: Needs assessment awarded to Fitch Associates; now getting started

-Watsonville has an engine at Caldor Fire along with other County units -Pajaro River Levee JPA moving forward

-Chief Honda retired from Police Department; Thomas Simms serving as interim

- 9.3 County Office of Education____ Jennifer Buesing
 - 9.3.1 All schools in County, public and private, open for in-person services
 - 9.3.2 COE and Public Health strong school collaborative team
 -Focused on vaccine, testing, contact tracing. Isolation of sick kids.
 -Doing thousands of tests each day; students and staff.

-State and private labs doing testing at schools.

-Also offering clinics elsewhere (e.g Cabrillo offering drive-through) -Open to anyone involved in childcare and schools.

-Focus on vaccine and testing – goal is to keep schools open. -Having cases in school. Exposure notices being sent. But very little transmission in the schools.

60 percent age 12 + vaccinated.

- 9.3.2 Cal OES grant enabled COE to partner with UCSC for Active Shooter Training, with many partners, and neighboring counties
- 9.3.3 Seeing increase in anxiety and issues with students.
- 9.4 Grant Updates
 - 9.4.1 FY2018 State Homeland Security Grant Program (SHSGP) (2.75-year grant through 5.31.21; award of \$349,660); grant closed out except the EMS HearNet Radio System project, which required an extension due to COVID-related delays; on track to be completed in September.
 - 9.4.2 FY 2019 State Homeland Security Grant Program (SHSGP) (2.75-year grant through 5.31.2022 award of \$359,856).
 Projects in progress: County Medical Surge Preparedness, Mass Casualty Incident Preparedness, and Active Shooter Bag for Health Services Agency/EMS; Personal Body Armor for Santa Cruz PD; Portable Bollards for Capitola; Personal Body Armor for Watsonville PD; Mobile radios for multiple fire agencies; and Mobile Medical Shelter Coordination for County EMS.
 Completed projects: Mobile X-Ray Machine (ID Hazardous/Explosive Devices) for the Sheriff's Office; Mobile Bomb Containment Vessel for the Sheriff's Office; Equipment for CERT training graduates; Ballistic Shields for Scotts Valley PD.
 - 9.4.3 FY 2020 State Homeland Security Grant Program (SHSGP) (2.75-year grant through 5.31.2023) award of \$356,972. New final application package was submitted on 1.28.2021 to align with 4 new National Priority Investment Justifications required by DHS/FEMA. Awaiting final approval.
 - 9.4.4 FY 2021 State Homeland Security Grant Program (SHSGP) (2.75-year

grant through 5.31.2024) award of \$341,759. Projects submitted in the Advance Application 4.21.2021 were updated to meet the 4 DHS/FEMA requirements addressing urgent national priorities for FY20 plus one new one for FY21. CalOES has reviewed and provided initial approval; awaiting further State and FEMA review.

9.4.5 FY2019 Emergency Management Performance Grant (EMPG) award (2year grant through 6.30.2021) was approved by Cal OES on 1.13.2020 for \$180,870. Grant requires 50% match (dollar-for-dollar). Grant closed out on time.

Completed projects: OES staffing; EOC/OES supplies; EOC Radio Charges; ISD/GIS Staffing to Support EOC Operations; EOC facility colocation costs; Mountain Community Resources citizen preparedness activities; and Resource Conservation District (RCD)/Firesafe Council planning and community activities.

 9.4.6 FY2020 Emergency Management Performance Grant (EMPG) award (2year grant through 6.30.2022) award of \$180,306. Grant requires 50% match (dollar-for-dollar). Final application submitted 2.2.2021; CalOES approved 2.28.21.
 Projects include OES/EOC staffing; travel for training/meetings; EOC

supplies; EOC radio charges; ISD/GIS staffing to support EOC operations; EOC network charges; and EOC facility co-location costs. Completed project: Mountain Community Resources citizen preparedness activities.

9.4.7 FY2020 Emergency Management Performance Grant (EMPG-S) COVID-19 Supplemental (grant through 6/302021) award of \$95,979. (No County match required: match provided by CalOES). Final application submitted 2.9.2021, approved 3.4.2021.

Project in progress: Portable Indoor Air Quality Measurement System for County buildings; Warehouse Inventory Management System and Staffing to organize and implement; Non-Contact Body Temperature Systems.

Completed Project: Santa Cruz Regional 9-1-1 Recruitment and Retention during COVID-19.
