2. Welcome and Introductions

This is an opportunity for Advisory Redistricting Commission members present and staff to introduce themselves and give an overview of the agenda.

3. Staff Presentations

- A. Redistricting Basics and Website: Presentation on the fundamentals of redistricting, the new legislative environment guiding redistricting in 2021, what is (and isn't) a community of interest, a timeline for the redistricting work ahead, and a quick overview of the website.
- B. Redistricting Software: Introduction to the software available to capture Communities of Interest via a form and mapping tool located on the County's redistricting website; an overview of Census data for redistricting; and a preview of the web-based redistricting software that will allow the public to create their own maps.
- C. Census Data for Redistricting: Presentation of the current population totals for each district and an opportunity for Commissioner discussion.

Presented

The commission discussed

- Changes in Census population data and distribution from 2011
- Effects of COVID pandemic and UCSC student population on Census population
- Current redistricting legislative criteria
- Effects of CZU Fire evacuations on Census population

Helen – Question on efforts made to encourage community members to participate in the Census who were impacted by the CZU Fire.

- M. Martinez Requested that any considerations to expand District 5 include residents with similar lifestyles such as North County and Bonny Doon.
- E. Westlund Requested information on priority to keep cities like Scotts Valley together in one district.

4. Communities of Interest Exercise

Testimony on communities of interest, which determine how neighborhoods or communities might be grouped together for the purposes of elections, will be taken through a mapping exercise and storytelling. Opportunity will be provided to members of the public attending the workshop in-person and online to share how they think district boundaries should be drawn to best represent their communities.

Helen – Provided input on the communities of Brookdale and Boulder Creek.
