Advisory Redistricting Commission Minutes - October 6, 2021

1. ROLL CALL

Present: Commissioners: O'Neil, Mosher, Reyes, Vie-Chair Radin*, and Chair Watkins *Vice-Chair Radin was experiencing technical difficulties and could not participate in the roll-call votes.

2. AGENDA REVIEW

The Commission discussed:

- Options for meeting with staff to review recommendations at the 10/13/21 meeting
