## **3. Santa Cruz County Redistricting Basics**

County staff will provide a brief presentation on the fundamentals of redistricting, the new legislative environment guiding redistricting in 2021, what is (and isn't) a community of interest, and the preliminary redistricting data from the 2020 Census.

## **4. Redistricting Website and Software**

GIS Staff will introduce the County's Redistricting 2021 website's capabilities to capture your description of a Community of Interest, and how to map it, an overview of the two phase release of Census data for redistricting, and a preview of the web-based redistricting software that will become available online once the final redistricting data is available for download from California's redistricting database, the Statewide Database (SWDB), estimated to occur on or about September 20, 2021.

## **5. Communities of Interest Exercise**

Staff will make available forms and paper maps for those attending in-person to describe and map which neighborhood or community might be grouped together for the purposes of elections. Those attending online will be directed to the online version.

## **6. Public Comment**

This is an opportunity for members of the public to provide share how you think district boundaries should be drawn to best represent your community. Each speaker will be permitted a maximum of three minutes each, with a maximum of 30 minutes set aside for this period.

This is an opportunity for Commissioners and staff to provide updates on Public Workshops and Public Hearings, an update on what's happening at the State and local level, and items associated with redistricting that may be of interest.
