In 2018, the Elections Code was amended to provide new requirements on establishing advisory redistricting commissions. Elections Code Section 23001 provides that a local jurisdiction may establish by resolution an advisory redistricting commission composed of residents of a local jurisdiction to recommend to the legislative body changes to district boundaries. The Board may determine the manner in which members are appointed (Elections Code Section 23002(b)) but shall not appoint themselves, other County elected officials, or their family members, staff members, or paid campaign staff to serve on the commission (Elections Code Section 23002(c)).
