SANTA CRUZ COUNTY TO BEGIN 2025 PAVEMENT MANAGEMENT PROJECT JUNE 10

June 4, 2025 – Santa Cruz, CA – The County of Santa Cruz Department of Community Development & Infrastructure will begin its 2025 Pavement Management Project on June 10, with work continuing through mid-August.
